**AN ORDINANCE APPROVING A VARIANCE FROM 25 FEET TO 20.9 FEET,
AMENDING THE FINAL PLAN OF KNOXVILLE POINTE PHASE III, A MULTI-
FAMILY RESIDENTIAL DEVELOPMENT LOCATED EAST OF NORTHTRAIL
MEADOWS SUBDIVISION AND WEST OF KNOXVILLE AVENUE, ALONG THE
SOUTH SIDE OF HICKORY GROVE ROAD**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS
AS FOLLOWS:

SECTION 1. That the final plan of Knoxville Pointe Phase III, attached hereto as Exhibit A, as amended by Exhibit B, and having the following legal description (Attachment A):

A subdivision of part of the NW ¼ of Section 29, T10N, R8E of the 4th Principal Meridian, Peoria County, Illinois

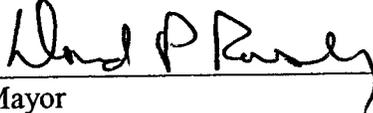
is hereby approved subject to the following condition:

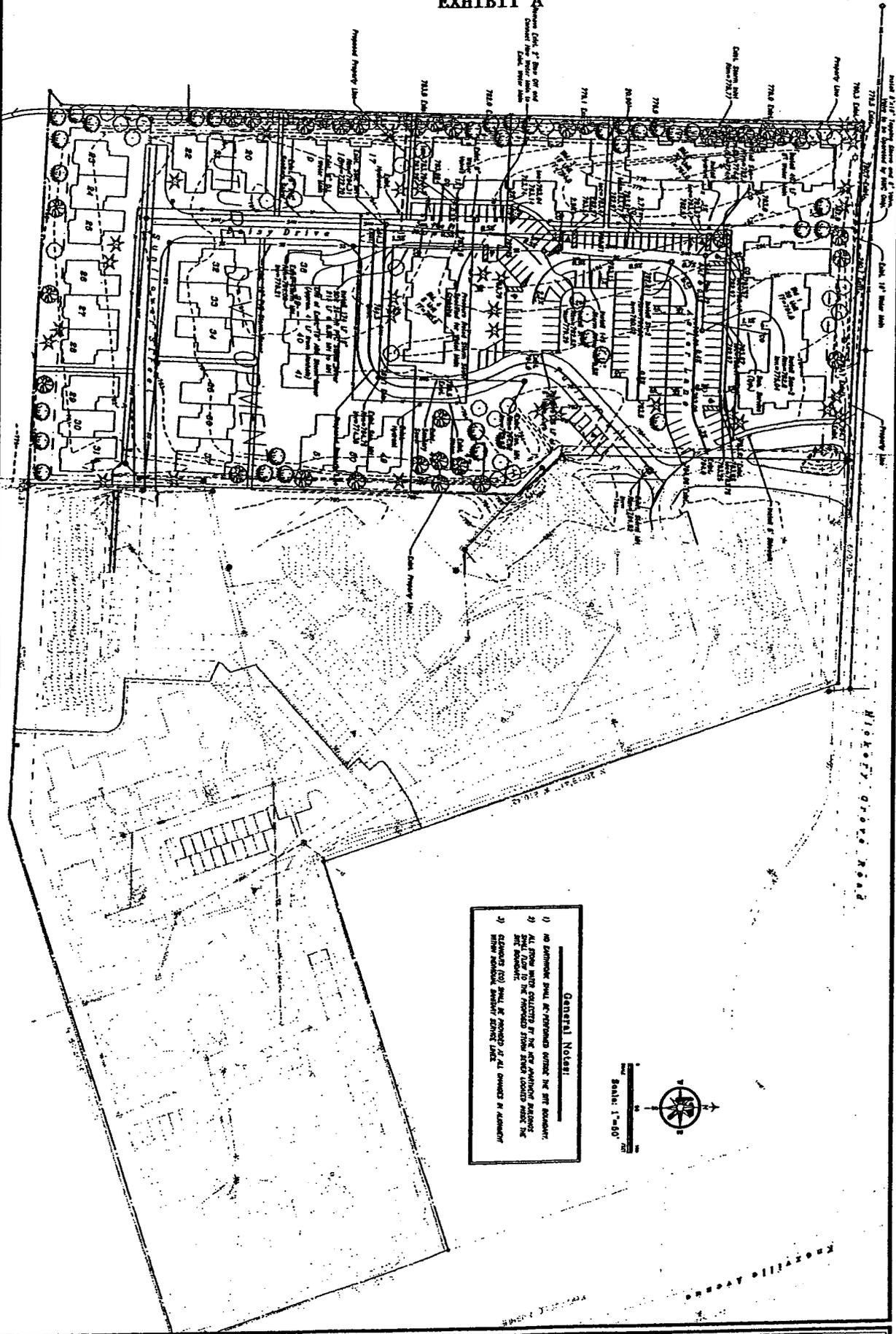

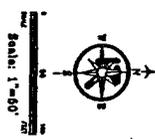

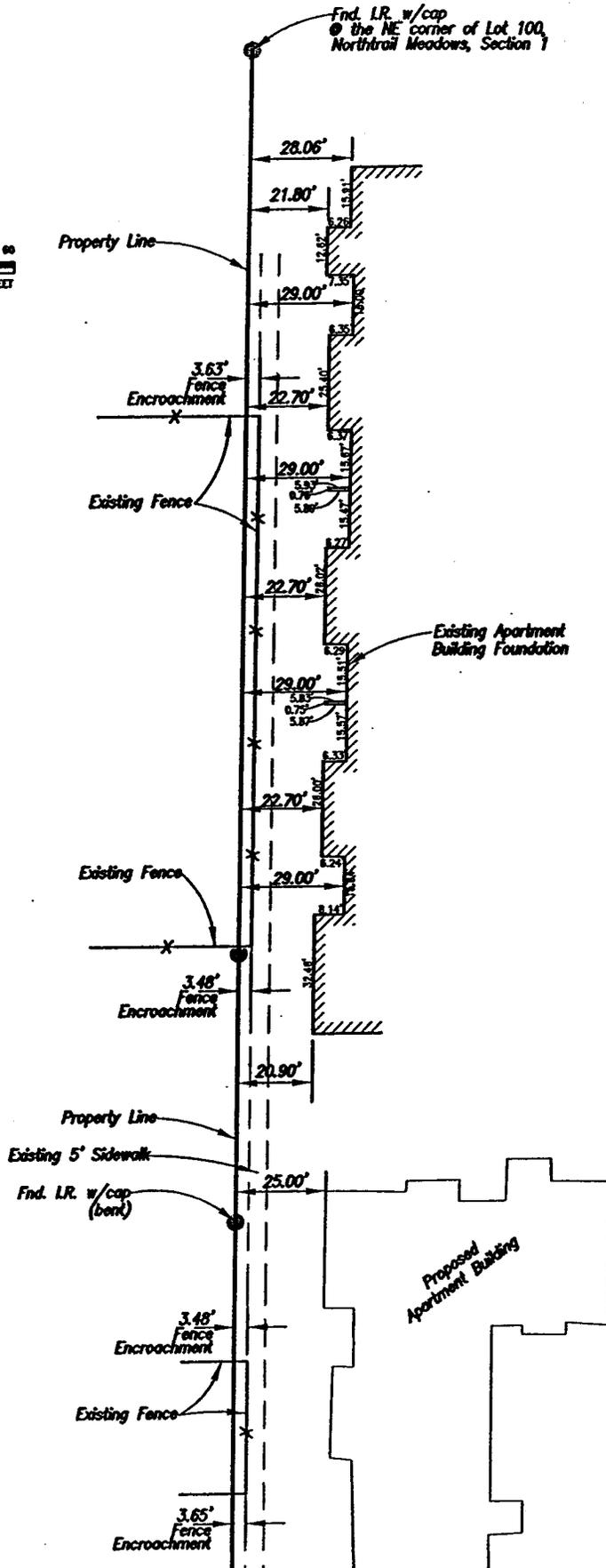

APARTMENT PARCEL

LEGAL DESCRIPTION

A part of Lot 100 of Northtrail Meadows Section One Subdivision as recorded in Book 6, Page 129 as Document Number 98-35143 in the Peoria County Recorder's Office, being a part of the Northwest Quarter of Section 29, Township 10 North, Range 8 East of the 4th Principal Meridian, Peoria County, Illinois; more particularly described as follows:

Beginning at the Northwest corner of said Lot 100; thence South $87^{\circ}-50'-49''$ East (bearings assumed for description purposes only) along the North line of said Lot 100, a distance of 372.00 feet; thence South $02^{\circ}-09'-08''$ West, a distance of 237.95 feet; thence South $47^{\circ}-35'-54''$ West, a distance of 116.88 feet; thence Southerly, along a curve concave to the East, having a radius of 60.00 feet, a chord bearing of South $09^{\circ}-41'-00''$ West, a chord length of 73.74 feet, an arc distance of 79.41 feet; thence Southerly, along a curve concave to the West, having a radius of 160.00 feet, a chord bearing of South $13^{\circ}-01'-01''$ East, a chord length of 83.98 feet, an arc distance of 84.97 feet; thence South $02^{\circ}-11'-51''$ West, a distance of 32.04 feet; thence Southwesterly, along a curve concave to the Northwest, having a radius of 42.50 feet, a chord bearing of South $47^{\circ}-11'-51''$ West, a chord length of 60.10 feet, an arc distance of 66.76 feet; thence North $87^{\circ}-48'-09''$ West, a distance of 129.38 feet; thence North $02^{\circ}-14'-12''$ East, a distance of 30.43 feet; thence North $87^{\circ}-45'-48''$ West, a distance of 129.13 feet to the West line of said Lot 100; thence North $02^{\circ}-09'-09''$ East, a distance of 517.89 feet to the Point of Beginning; said parcel containing 4.08 acres, more or less.
