LEGAL DESCRIPTION:

THE NORTH 35 FEET OF LOT 1 OF LONGWOOD SUBDIVISION, THE SOUTH 45 FEET OF LOT 2 OF LONGWOOD SUBDIVISION, THE NORTHERLY 70 FEET OF LOT 2 OF LONGWOOD SUBDIVISION, AND THE SOUTHERLY 15 FEET OF LOT 3 OF LONGWOOD SUBDIVISION OF A PART OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 17, TOWNSHIP 9 NORTH, RANGE 8 EAST OF THE FOURTH PRINCIPLE MERIDIAN MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LONGWOOD SUBDIVISION AS RECORDED IN PLAT BOOK "Y" PAGE 56 IN THE PEORIA COUNTY RECORDER'S OFFICE, THENCE NORTH 09°00'10" WEST ALONG THE EAST LINE OF LONGWOOD SUBDIVISION 80.00 FEET TO A FOUND IRON PIPE SAID PIPE BEING THE POINT OF BEGINNING OF THE SUBDIVISION TO BE DESCRIBED; THENCE SOUTH 89°51'52" WEST A DISTANCE OF 140.96 FEET TO A SET IRON ROD SAID ROD BEING ON THE COMMON LOT LINE BETWEEN LOTS 1 AND 7 OF LONGWOOD SUBDIVISION; THENCE ALONG SAID COMMON LINE NORTH 01°39'21" EAST A DISTANCE OF 149.97 FEET TO A FOUND IRON PIPE SAID PIPE MARKING THE COMMON WESTERLY CORNER OF LOTS 2 AND 3 OF LONGWOOD SUBDIVISION; THENCE ALONG THE COMMON LOT LINE OF LOTS 3 AND 6 OF LONGWOOD SUBDIVISION NORTH 19°27'45" WEST A DISTANCE OF 15.78 FEET TO A SET IRON ROD; THENCE NORTH 89°50'22" EAST A DISTANCE OF 141.84 FEET TO A FOUND IRON PIPE ON THE EASTERLY LINE OF SAID LONGWOOD SUBDIVISION; THENCE ALONG SAID EASTERLY LINE SOUTH 09°00'10" EAST A DISTANCE OF 84.90 TO A POINT; THENCE CONTINUING ALONG SAID EASTERLY LINE SOUTH 09°00'10" A DISTANCE OF 79.95 FEET TO THE POINT OF BEGINNING. SAID DESCRIBED PARCEL CONTAINING 22,881 SQ FT OR 0.525 ACRES MORE OR LESS AND ALL BEING SITUATED IN THE CITY OF PEORIA, ILLINOIS. 

