**City of Peoria, Big Picture Peoria Dedicate New Mural**

The city of Peoria and Big Picture Peoria dedicated a new mural on the Niagara Parking Deck, 111 SW Adams Street. Speakers at today’s event included Peoria Mayor Rita Ali, Mark Misselhorn Vice President of the Big Picture Peoria board, Gilmore Foundation President Laura Cullinan, and Community Foundation of Central Illinois CEO Mark Roberts. The event was held downtown at the OSF HealthCare System building.



In her comments, Mayor Ali stated, “Public art has the unique ability to transform spaces and inspire us in our daily lives. It’s a reminder that beauty can be found in unexpected places—even parking decks--and that our public spaces belong to everyone.”

Featuring the word “Peoria,” along with the faces of six community members from the Peoria area, the 32-foot-tall and 35-foot-wide piece is titled “Live Greater.” It was created by Alex Carmona, a master relief printmaker who specializes in woodcuts, reduction woodcuts, and wood

carvings/engravings. The mural was underwritten with funds from the Gilmore Foundation, Community Foundation of Central Illinois, and Tourism Reserve Funds from the city of Peoria.

Big Picture Peoria has presented other projects in Peoria, including Abraham Blue, the 50-foot mural on the side of the Peoria County Courthouse, Portraits of Peoria, on the Main Street side of the Peoria Public Library downtown location, and the “Find Yourself” mural at Metro Center. This fall they will host The Big Picture Film Festival on November 23 at the Peoria Riverfront Museum.

The project received final approval for a special use permit by the Peoria City Council on August 27 following a recommendation by the Planning and Zoning Commission and a review from the Public Arts Advisory Commission.

### **Intersections, Roads to be Impacted on September 14 for the La Caravana Event**

Beginning at 1 p.m. and lasting until 7 p.m. on Saturday, September 14, the La Caravana event and vehicle parade will occur. The event is sponsored by Maria Miranda.

#### **La Caravana Meet**

- The La Caravana Meet will be held from 1 p.m. to 2:30 p.m. at the Peoria RiverPlex – Recreation and Wellness Center.

#### **La Caravana Parade**

- The parade starts at 2:30 p.m. and will last until 3 p.m. at the Peoria RiverPlex – Recreation and Wellness Center. The parade will travel north on Irving Street before traveling east on Bond Street and then north on Wayne Street.
- From Wayne Street, the parade will travel east on N.E. Perry Avenue. The parade will head south on Evans Street, then west on N.E. Monroe Street, and finally north on Morgan Street to end at Morton Square Park.

Rolling lane restrictions will go into effect on these City streets during this time. Drivers should exercise caution along the route. The use of alternative routes is advised.

#### **La Caravana Fiesta**


- The La Caravana Fiesta will start at 3 p.m. and will last until 7 p.m. at Morton Square Park, following the conclusion of the parade.



### **Water Street will be Closed on Sunday, September 15 for Go Day 2024**

Beginning at 7 a.m. and lasting until 11 p.m. on Sunday, September 15, S.W. Water Street between Liberty Street and the Peoria Riverfront Museum Parking Deck entrance will be closed. The closure is necessary for Go Day 2024 sponsored by Choose Greater Peoria.

Drivers should be mindful of the closure. Through traffic should use S.W. Washington Street as a detour.



### **Parking Restrictions**

- On-street parking restrictions will be in effect on S.W. Water Street between Liberty Street and the Peoria Riverfront Museum Parking Deck entrance.

### Peoria Fire Department Prepares for Fire Prevention Week

The Peoria Fire Department is preparing for Fire Prevention Week, which will take place from Oct. 6, 2024-Oct. 12, 2024. Division Chief of Prevention Nate Rice and his team of investigators, inspectors, and firefighters will visit all 13 Peoria Public Primary Schools to discuss the importance of smoke detectors in the home. For Fire Prevention Week, the National Fire Protection Association (NFPA) develops curriculum geared towards children in grades K-2nd to help stress the importance of fire prevention. By the end of Fire Prevention Week, Division Chief Rice and his team will talk to over 3,000 children, starting the week of September 23.



### Peoria Public Works – Jefferson/Adams Conversion Update

Sidewalk removal work has begun on the north side of the intersection of Liberty Street and SW Adams Street. The sidewalks near 300 SW Adams Street are closed to pedestrian access.

Sidewalk work continues at the intersection of Hamilton Boulevard and NE Adams Street, near the Peoria County Courthouse. Work also continues at the intersections of Fulton Plaza and SW Adams Street. Sidewalks near 123 and 201 SW Adams Street have limited pedestrian access.

Sidewalk removal will start on the north side of the intersection of Harrison Street and SW Adams Street, near 400 SW Adams Street, in the coming weeks.

Pedestrians should continue to use caution near these closures and cross the street at the next available intersection.

Lane and parking restrictions remain in effect along SW Adams Street. On-street parking restrictions are marked. Drivers should look for unbagged, available parking meters for on-street parking. **If parking meters are bagged with “No Parking” signs, drivers should not park at those spots. Parking at bagged parking meters will result in a ticket and vehicle removal at the owner’s expense.**

Additional parking, lane, and sidewalk restrictions will be forthcoming as the Adams Street and Jefferson Avenue One-Way to Two-Way (OWTW) Conversion Project progresses.

This summary document is produced on a weekly basis. It is used as an agenda for the City Development Review Board and as a transparency tool to allow the public to be aware of development in Peoria.

### 1. Summary Information

- **One Stop Shop** is held every Monday at 1:30 PM virtually. We also offer an in-person option the first Monday of each month at Distillery Labs at 201 SW Adams St. This is a free service for anyone who wants to discuss development with staff from various city departments, local utility companies, the Peoria County Health Department, and CityLink.
- **Development Center Permits** can typically be issued immediately and/or do not require an extensive review period. These permits include most trade (electrical, plumbing, HVAC, etc.) permits, repair permits, new single-family residential construction, alteration/additions, and demolitions.
- Each permit application includes a self-reported value of the project. The **Total Value of Development (YTD)** is the sum of these reported values.

### 2. Development Review Board Projects

- The **Development Review Board** is a group of City staff, local utility representatives, and other local government agencies that review and comment on more complex development applications and cases that are required to go to a public hearing.
- Items listed below with the prefixes HPC, PZC or ZBA in the first column are considered **Plans**. **Plans** are development applications that require multiple departments to review for compliance and include a public hearing before a City Commission; in some cases, **Plans** may also require a final decision by the City Council.
- All other items listed below are **Building Permits**. **Building Permits** are development applications that require multiple departments to review for compliance but do not require a public hearing or City Council review.
- The **Staff Assigned** to each item is the primary contact person for any inquires.






## Peoria Cares Communication Transactions During the Month of August 2024






## Peoria Cares August 2024 Complaints by Category



### Peoria Cares August 2024 Complaints by Department




Peoria Cares August 2024 Complaint Status (as of 9/06/24)






## Overall Need Category of Peoria Cares Calls Not Resulting in a Peoria Cares Ticket- August 2024




